## Guidelines for applications to the Ventures Subsidy Fund

### *The aims of the fund*

Ventures runs a Subsidy Fund to ensure that no CYFA, Pathfinder or Explorer member is prevented from going on a Venture because he/she cannot afford the full fees. However, the Fund is limited, and therefore we set certain criteria in order to ensure that we are awarding grants to those who are most in need of subsidy:

1. In applying for a grant from the Subsidy Fund, you are confirming that the award of a subsidy will enable a young person to go on a Venture who would otherwise be unable to go.
2. Generally speaking, the Subsidy Fund exists to support those households where income is particularly low; often this will mean that parents or guardians will be receiving welfare benefits such as income support. If this does not apply in your case, you should judge whether your application fits with the ethos of the Fund.
3. We will also support families where three or more siblings are going on Ventures in the same year and where the family's finances cannot afford the fees for all of them.
4. The Subsidy Fund is one of a number of options for funding; others include young people's home churches and Trust Funds. We expect any grant from the Ventures Subsidy Fund to be matched by awards from other sources.

### *How much can you request?*

You can request a grant from the Subsidy Fund for an amount up to one third of the Venture price. (For overseas Ventures we normally give a maximum grant equivalent to the largest grant which could be made to a UK-based Venture.)

### *Which applications will be successful?*

When you make an application, we ask you to confirm that you meet the criteria shown above. Applications are not normally refused, but we do not have unlimited funds, and we may not be able to meet applications which reach us close to the time of the Venture.
